The Partner shall also be liable, in accordance with the regulations of civil law, for any damages resulting from the private use of equipment and IT services provided by the MTVA and arising due to misuse or non-contractual use.

The Partner shall be obligated to familiarize itself with and shall accept to be bound by the relevant IT regulations of the MTVA, and shall be fully liable for any violation of such regulations in accordance with the regulations of civil law.

The Partner shall not be entitled to make the equipment and services - owned (managed) by the MTVA - it uses accessible to third parties. The Contractor shall be fully liable for any violation of this obligation in accordance with the regulations of civil law.
